## Semtech: Metals Procured from “Conflict Areas”

Semtech Corporation is very aware of and sympathetic to the plight surrounding the areas commonly referred to as “conflict areas” as identified by the Responsible Business Alliance (RBA), the Global e-Sustainability Initiative (GeSI), and section 1502 of the Dodd-Frank Act enacted in 2010.

Semtech Corporation is committed to taking positive measures to seek to ensure, to the extent reasonably practicable in light of existing supply chain validation and auditing capabilities, that the products within our supply chain are not fabricated nor assembled with metals whose origin traces back to an area within these “conflict areas” and smelted by nonconforming non-valid smelters.

Semtech Corporation continues to seek to secure assurances from all of our suppliers, confirming that the metals procured for use within our products — including gold (Au), tantalum (Ta), tungsten (W), tin (Sn), cobalt (Co), copper (Cu), graphite, lithium (Li), mica, and nickel (Ni) — were not obtained from sources whose business practices are not in-line with and supportive of the avoidance and non-use of conflict area minerals. While the industry has made significant progress in tracing material origins since the implementation of the Dodd-Frank Act, we acknowledge the ongoing challenges in providing absolute guarantees that all sources of supply are free of “conflict area” minerals.

Semtech Corporation will continue to undertake enhanced due diligence and continuously monitor the procurement activities of our suppliers as they relate to the fabrication and assembly of our products, to ensure compliance with our policy. Our due diligence process includes an annual supplier survey conducted in Q3 using the latest CMRT (Conflict Minerals Reporting Template) and EMRT (Extended Minerals Reporting Template).

In addition, Semtech Corporation will continue to actively monitor and stay informed of relevant activities, reports, and proposals for supply chain improvements by organizations such as RBA and GeSI, and others, as our industry continues to work toward a supply chain that is reliably and verifiably free of “conflict area” minerals.
